
An interconnected social system: a balanced planet for balanced people

Environmental, social and economic crises can no longer be considered as distinct spheres. The **World Economic Forum's**<u>Global Risks Report 2025</u> and the <u>Planetary Health Alliance</u> paint a clear picture: the balance of the planet's health and that of its inhabitants as one.

Climate change, pollution, the loss of biodiversity and the growing pressure on natural resources are not just environmental threats, as they impact directly on human balance and on social and economic stability.

Air quality as **ecosystem balance** determine people's living conditions and influence the spread of diseases, economic security and mental health.

Extreme heat waves, disease and illness caused by pollution, water insecurity and forced migration are just some of the most evident consequences.



The human footprint on the Earth's natural systems is stronger than ever before

We are overusing the available resources of **the only habitable planet we are aware of.** Since 1950 the human population has increased by nearly 200%, fossil fuel consumption by over 550% and sea fishing by over 350%.

We have built dams in close to 60 % of our rivers, done away with nearly half of tropical and temeperate forests, we use nearly half of available fresh water every year and have taken over nearly 50 % if our planet's habitable surface to nourish ourselves.

Everything is connected: changing our planet's *natural systems* will in turn affect us, and not always in the ways we might expect. *Understanding* and *acting* on these *challenges* requires an extremely strong collaboration if we wish to defend our health and the planet's.



Damage mitigation is no longer enough.

Concomitantly, swift changes in the world of work, technological evolution and geopolitical tensions are rewriting the notion of social and exonomic security.

In this accelerating and unstable scenario, traditional responses appear slow and fragmented, while challenges such as the ones we have, require swift and scalable system solutions.

It is no longer enough to **mitigate** damages: **a new paradigm is called for,** one able to to connect **social progress and sustainability.**

In our time, the crucial challenge is to regenerate existing models and build new resilient economies.




Startups & innovation: turning complexity into positive Impact



Why to apply?

Since 2016 we have dealt with the launch and implementation of 18 acceleration programmes accompanying 110 social impact startups totalling €50M funding to date.

Over the 84% of the startups that received SocialFare Seed from 2017 to date successfully received further funding after our investment.

Thanks to our multidisciplinary team's expertise and to the prestigious network of mentors, advisors and impact investors we are able to offer a unique expert advice programme and equity investment for the generation of impact entrepreneurs.



We invest in your impact startup

Through SocialFare Seed



SocialFare Seed invests up to € 1mIn per year in social impact startups accelerated by SocialFare.

SocialFare Seed is a private investment fund that supports startups and businesses accelerated by SocialFare.

If eligible, each startup/business can receive a seed fund of up to 150K€ (20% of which to be paid to SocialFare for acceleration services) in exchange for a variable percentage of equity, according to the valuation of the company.

The investment is paid in cash at the beginning of the program..

We invest in your impact startup

Startups selected by SocialFare for acceleration will be awarded a seed fund of up to €150K in cash (20% of which to be paid to SocialFare for acceleration services) in exchange for a percentage of equity up to 15%. The investment will be performed by SocialFare Seed S.r.l.



SocialFare Seed is a private company established by impact investors such as the FINDE (Ltd partnership) Family Office, bank foundations such as the Compagnia di San Paolo, the CRC Foundation. SocialFare is also a partner and promotes a systemic model to establish and develop new social entrepreneurship. It is the one and only of its kind in Italy and is extremely innovative.

Convertible funding

The investment will be a convertible, that is a non interest-bearing convertible in the startup's equity. A convertible is a finance instrument used in the early stages of a startup given it is a cheap, swift means to gather funds without having to formally add a new equity partner at the start given the costs this entails. The conversion into equity by SocialFare Seed will take place in the event of a good performance of the startup or alternatively if it raises capital from investors in the three years following the signing of the contract.

Resource transfer

Resource transfer will take place in two steps: before the beginning of the acceleration program and on achieving shared objectives.

Contract

There is a standard contract for all startups a draft of which will be sent to the project/business team before the Selection Day, so they may view it. In the event of them being selected and joining the acceleration program the startup undertakes to accept and sign the relevant seed funding agreement/contract.

Type of company

If your business idea is selected you will undertake to establish the company within two months from selection, and to register with the Company Register (Registro delle Imprese).

Total investment and equity share

SocialFare Seed retains the right to vary the exact amount of the investment and the percentage of the equity; these clauses are negotiated with the team upon admission to the acceleration program.




